Scott is also a partner with Social Venture Partners Chicago, a partnership of philanthropically-minded individuals focused on building a scalable social enterprise community in Chicago. He also serves on the Board of the Lake County Community Foundation, serving the needs of Lake County's most vulnerable citizens.
